By talking to his former neighbours he tries to determine the circumstances of the murder of his father and younger brother.

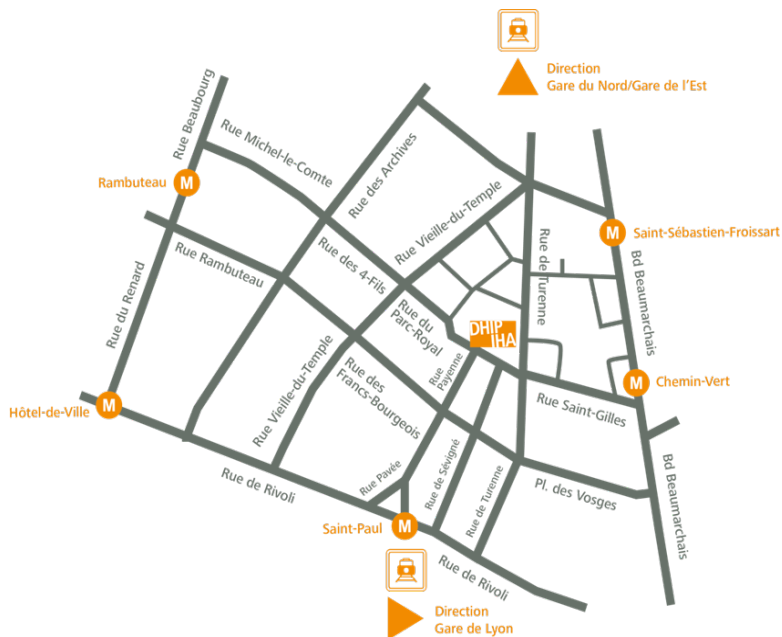
